- 5 bids received
- **Carpet One** Armstrong brand 20 mill plank flooring **\$14,436.50**. This is an ALL-INCLUSIVE final price. **It includes all labor and materials for the finished job.**

Others bid a slightly lower price but will add for “extras” they find.

- This is for the FIRST floor only. The second floor will be on next year’s budget.
- This purchase will over-extend the Circuit Clerk’s budget for 2024. The budget will be amended in November to cover this amount. This is a **HEALTH** issue and should be handled immediately.

SB 190 is being rewritten as SB 756

- In this new bill:
 - You are eligible at age 62.
 - You will be billed for the entire amount of your taxes but will receive a “credit” for any amount of increase in that tax.
 - All taxing subdivisions (schools, seniors, etc.) will be affected by this.
- Nothing is said about a requirement to apply for this status.
Otherwise, we would not know the person’s age.
- This must be passed and then signed by the Governor. We would then choose whether to act on the final version.
