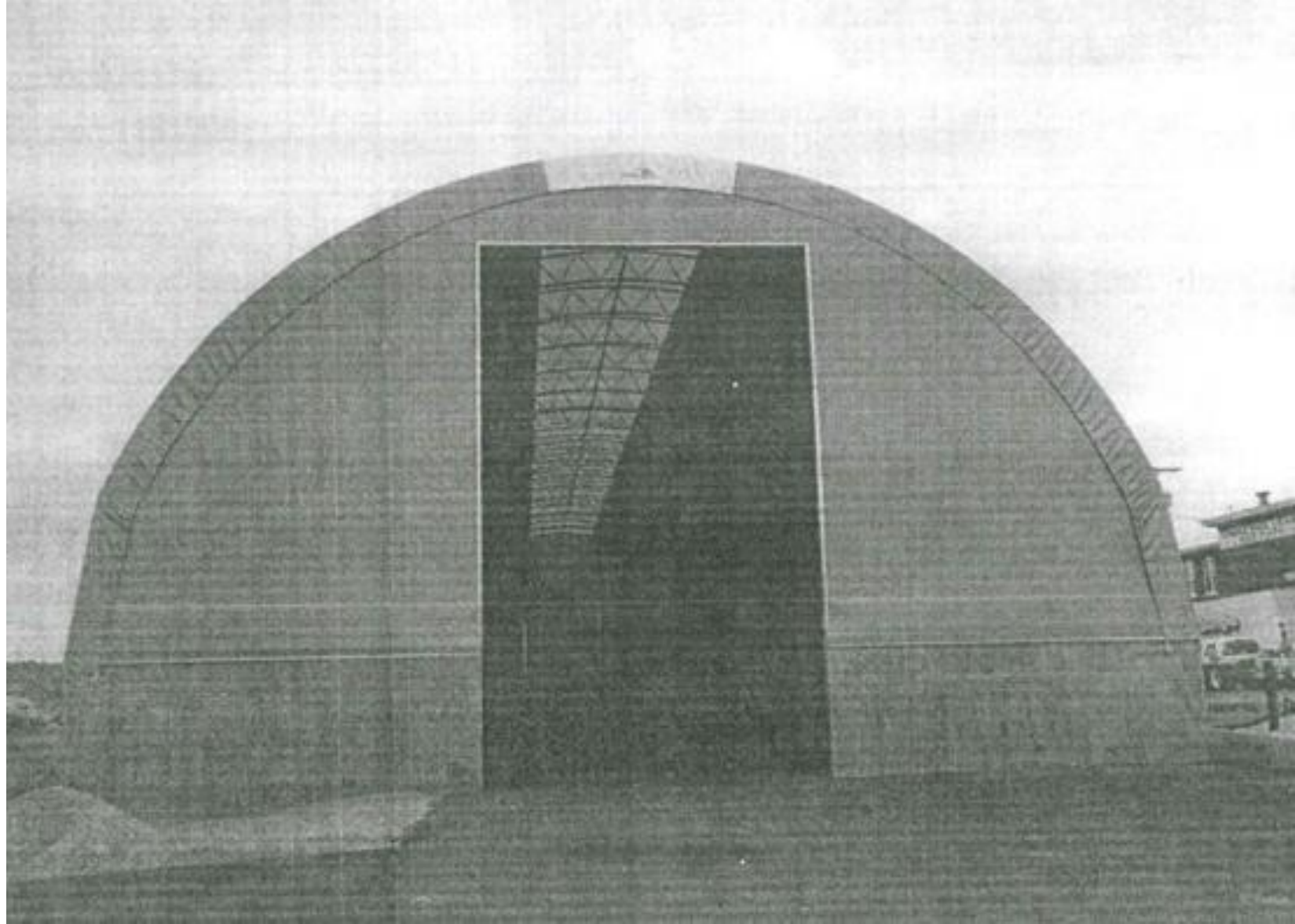

Forensic Expert Requisition

Re: Approval of REQ50735

Gentlemen,

Our office is prosecuting a Child Abuse/Neglect Resulting in a Death case from 2014, St. v. Tyler Finley case number 25SF-CR00206 previously charged under case number 14SF-CR01715-01.

The Forensic Pathologist Mary Case is the States expert witness who examined the deceased child's brain and eyes. She is a world-renowned expert in baby shaken syndrome, which the State, the Doctors at Children's Hospital as well as the local Medical Examiner, Dr. Russell Deidiker believed that to be the cause of the death in this case. The invoice for her review of the medical records and summary were not something that could have been open for bid for several reasons. One, she was the Dr. who examined the child's brain and eyes. Two, there was no way for her to provide a quote or contract before looking through the medical records. Further, the Defense is using a medical expert as well and the best way for our office to try this case and seek justice for this baby at a Jury Trial is to use a medical expert as well. Given this information we request that you, the Commissioners approve her invoice and our requisition in the amount of \$4,950.00.
