Comp time limit

- Effective April 7, 2025 the limit of comp time on any employee's records is set as a MAXIMUM of 80 hours.
- Each employee **WILL** receive pay for his/her comp time (over the 80 hour limit). We must set up a system to enable this due to budgetary considerations.
- CURRENTLY (and with the **current** maximum limits), there are 6 employees with more than their limit of COMP hours.

Payment of overtime hours

- Effective April 7, all overtime for the current pay period will be paid in dollars and not be added to COMP time.
- Effective April 7 the Maximum COMP hours for ALL employees is 80. The employees will NOT lose any accumulated hours over their 80.
- If the employee specifically requests that he/she be given COMP hours instead of cash, his/her comp hours may not exceed 80 hours of total COMP time.
- We are looking at a system of paying down all comp hours. This must be done over a period of time due to the very large amount of dollars involved. Those dollars will come from the department's budget and this must be considered.
- Also, the employee should look at his/her tax ramifications in taking the money all at once. They may decide to divide the payments over several pay periods.
