Property taxing district error:

reimbursement in the amount of \$1,397.46. Commissioner

Mullins made a motion to approve his request.

Amendments Budget to Actual: County Clerk, Kevin Engler mentioned that the County Offices have until 17th of January to get their expenses in and it will have to make another finalizing to the budget before January 31st. Ozone Closeout Report for 2019:

Commissioner Mullins read the Ozone Closeout report. In 2008 SEMO RPC created the Air Quality Committee and established standards in response to National ambient air quality standards. It is comprised of elected officials from Iron, Madison, Cape Girardeau, Bollinger, St. Francois, and Ste. Genevieve Counties. No action was needed.

Request for New Hire:

Pamela Williams made a request to hire Jenny Orwig, not a new employee, a replacement. Commissioner Mullins made a motion to approved Mrs. Williams request. Commissioner Wilkinson seconded the motion. All were in favor and the motion passed.

Write off Real Estate Taxes:

Pamela Williams made the recommendation to write off real estate taxes. She stated that there were 2 different types. A fifth year write off in the amount of \$235.18 and the amount that will be going to the trustee is \$22,071.35. This amount is higher because these have been through the tax sale for three years and have not sold. When the trustee, Barb Shelton sells those, they will be put back on the books at a partial rate. Commissioner Mullins made a motion to accept Mrs. Williams recommendation. Commissioner Wilkinson seconded the motion. All were in favor and the motion passed.
