**GENERAL BUSINESS:** 

BID OPENING ELECTION SUPPLIES COUNTY CLERK Bids were opened on January 15, 2019 for the April 2, 2019 General Election. There was one bid received from Henry M. Adkins & Son in the amount of \$25,917.03. County Clerk, Kevin Engler recommended the bid be accepted. Commissioner Mullins made a motion to accept the bid from Adkins. ## BLANKET COURT ORDER REAL ESTATE TAXES

The Collector presented to the Commission a blanket court order concerning real estate taxes to be taken off the tax books for the year 2013 in the amount of \$843.88 and for the years 2013 through 2018 in the amount of \$12,049.22. **EMERGENCY DECLARATION** Presiding Commissioner Harold Gallaher made an emergency declaration to replace the heating unit at the Juvenile Detention Center. Bids were obtained from Koppeis Heating & Cooling, Briley Heating & Cooling, & Crystal Heating & Cooling. Koppeis Heating & Cooling had unit in stock & came in at the lowest bid of \$8,930. The unit was installed and is up and running.

# ASBESTOS ABATEMENT

EMERGENCY DECLARATION Asbestos was detected when the flooring in Division 3 Courtroom was being replaced. Containment area Consisted of entire Southeast Courtroom. Abatement was conducted by Midwest Environmental Studies on January 7, 2019. All results meet EPA clearance criterial for reoccupancy. The courtroom flooring is finished and is back in operation.

## TOURISM RESOLUTION FY20 MMG APPLICATION

Commissioner Patrick Mullins presented the Commission with a resolution for the Official Destination Marketing Organization (DMO) for St. Francois County to participate with adjacent counties who share several tourism attractions in common and to partner together in making an application to the Marketing Matching Grant Program in FY20. Commissioner Mullins made a motion to partner with Ste. Genevieve County to apply for the grant. Commissioner Wilkinson seconded the motion. All were in favor and the motion passed.

ROAD & BRIDGE NEW EQUIPMENT DUMP TRUCK Road Supervisor, Clay Copeland & John Gross spoke to the Commission about the need for a new Dump Truck. Clay explained that a new truck was to be purchased the end of 2019 but with the loss of one of our older tandem dump trucks it is necessary to replace as soon as possible. The process of ordering and obtaining new dump truck will take months so it is possible the new dump truck may not be here until the end of 2019 beginning of 2020.

Commissioner Wilkinson made a motion to purchase a new dump truck. Commissioner Mullins seconded the motion.

**DEPARTMENT REPORTS:** 

AUDITOR/BULK MAIL

Auditor, Louie Seiberlich, addressed the Commission about the credit St. Francois County has with Presort Mail. When Presort mail bought Direct mail the County had a credit of \$6322.01. Presort Mail would like to settle this debt by crediting the County's account each month until the \$6322.01 is paid back. The amount varies each month so there is no timeline when debt will be repaid. Auditor Seiberlich has also recommended that in the future we do not pay in advance for any products or services to keep this from occurring again.

ROAD & BRIDGE ACCIDENT

Highway Supervisor, Clay Copeland spoke about the accident that occurred with one of our experienced Road & Bridge drivers during recent snow storm. The driver was on Germania Road trying to clear road when he came upon two cars stopped on roadway. He attempted to back up but slid off the road because of the icy conditions, rolling the dump truck before coming to a stop. Driver was wearing seatbelt and was taken to hospital to be checked out. The dump truck is a total loss, but driver was only shaken up & not seriously hurt.
