GENERAL BUSINESS:

SALES TAX REPORT TREASURER St. Francois County Treasurer, Kerry Glore, presented the Commission with the sales tax report for the month of May. Treasurer Glore stated the County is up 5.5% from May 2018 through May 2019 and 4% over for the year.

WAIVING PENALTY & INTEREST L.I.F.E. INC.

In 2016 L.I.F.E. Inc. purchased parcel 10-90-31-01-007-0011.01. L.I.F.E. is tax exempt so there are no taxes for 2017 & 2018. However, 2016 taxes were not paid. The L.I.F.E. Inc. is asking the penalty & interest be waived in the amount of \$1,044.68. Commissioner Wilkinson made a motion to waive the penalty & interest in the amount of \$1,044.68 due to the L.I.F.E. center not realizing taxes were due. Commissioner Mullins seconded the motion. WATER SOFTENER JDC

Commissioner Gallaher is going to ask the extension office if any 4-H family would be interested in removing the old green house as well as the rabbit cages and chicken coops. If no one is interested in salvaging the greenhouse SFC Road & Bridge department will destroy and remove the old green house. Commissioner Wilkinson made a motion to remove and or repurpose the old green house. Commissioner Mullins seconded the motion. All were in motion and the motion passed.
