BID AWARD (PARTIAL) ROAD PROJECTS

The Road & Bridge department placed eight (8) roads for paving for the 2019 fiscal year on bid. It was the recommendation of Highway Superintendent John Gross to award the paving projects for Hildebrecht Road, awarded to Vern Baumann, Wortham Road, and Oak Ridge awarded to Lead Belt Materials. Upon the recommendation of Hwy Superintendent, Commissioner Wilkinson made a motion to award the three (3) road projects to Lead Belt Materials & Vern Baumann. Commissioner Mullins seconded the motion. All were in favor and the motion passed.

APPROVAL OF SERVICE CONTRACT-VANGUARD

Assessor, Dan Ward, made a recommendation to extend the Contract and License Agreement with Vanguard to include the module that will provide the Assessor, property owners, Board of Equalization, and many others with comparable properties to the subject property in question. The Assessor's office did not budget for the cost of this extra Module so Vanguard has agreed to delay payment of \$2,950.00 until 2020.
