## SALARY SCHEDULE/JOB TITLE CHANGES

Human Resource Director, Corey Schrum, addressed the Commission on October 7, 2019 regarding increasing the beginning wages and the pay adjustment for current employees. The Auditor ask the Commission to table the request until further review. Ms. Schrum met with the Commissioners and the Auditor since October 7.

## SALARY SCHEDULE CON'T.

Ms. Schrum presented the Commission with figures on increasing the starting wages to \$12.00 per hour. Commissioner Mullins made a motion to raise the starting wages to \$12.00 per hour to be more competitive in our area. Commissioner Wilkinson seconded the motion. All were in favor and the motion passed. Ms. Schrum proceeded to request that the pay increase for current employees be adjusted this year from receiving a \$.25 per hour raise to a \$.50 per hour raise to offset the beginning wage increase for new employees. Commissioner Wilkinson made a motion to adjust the current employees raise to \$.50 beginning January 1, 2020. Commissioner Mullins seconded the motion. All were in favor and the motion passed.

## **GENERAL BUSINESS:**

#### 2020 HOLIDAY SCHEDULE

The 2020 Holiday Schedule was presented to the Commission by County Clerk, Kevin Engler. Commissioner Mullins made a motion to accept the Holiday Schedule. Commissioner Wilkinson seconded the motion. All were in favor and the motion passed.

24<sup>th</sup> Judicial Family Treatment Court requested to bid outpatient services for substance abuse treatment. There were two bids received; Presbyterian Children's Homes & Services, and Great Mines Health Center. The bids will be taken under advisement until further review.

# REQUEST TO BID 4 COMMERCIAL GARAGE DOORS/ RD & BRIDGE

Highway Supervisor, Clay Copeland, requested to bid Four (4) Commercial, insulated, automatic garage doors for the Road & Bridge Department. Mr. Copeland spoke regarding when Road & Bridge moved to the new facility there were certain renovations that would need to be done in the future. Road & Bridge has money in the budget to cover the cost of renovations. This project will make the flow of traffic into the barn much easier and quicker for the road & bridge crews. Commissioner Wilkinson made a motion to bid four (4) Commercial Garage Doors for Road & Bridge. Commissioner Mullins seconded the motion. All were in favor and the motion passed.

# HIRING TWO (2) SEASONAL EMPLOYEES/COLLECTOR

Collector, Pam Williams, requested to hire two (2) seasonal employees. Ms. Williams explained that during tax season additional staff is needed. No benefits will be paid to these employees. Commissioner Mullins made a motion to hire two seasonal employees in the Collector's office during tax season. Commissioner Wilkinson seconded the motion. All were in favor and the motion passed.

## HUMAN RESOURCE DIRECTOR SALARY

County Clerk, Kevin Engler, addressed the Commission regarding the salary of the Human Resource Director. Mr. Engler explained he was approached by the Commission to consider when filling the role of Chief Deputy in his office that he would also look at making the position a Human Resource/Chief Deputy position. Ms. Schrum came to the County Clerk's office with HR experience and dual Bachelor's degrees. County Clerk, Kevin Engler, is requesting that Ms. Schrum's rate of pay starting January 1, 2020 be \$24.00 per hour. Commissioner Wilkinson made a motion to set the pay for Ms. Schrum at \$24.00 per hour beginning January 1, 2020. Commissioner Mullins seconded the motion. All were in favor and the motion passed.

# FINAL ASSESSED VALUATIONS

County Clerk, Kevin Engler, presented the Commission with the Final 2019 Assessed Valuations for the County. A comparison was done from the final assessed valuation of 2018 showing an overall increase of 6.77%.

#### E-PAY TAXES/COLLECTOR

Collector, Pam Williams, requested extending a contract for the E-pay system. Ms. Williams explained how there are two different vendors, but that both are needed because of various duties of each. Commissioner Wilkinson made a motion to use both vendors for the E-pay system. Commissioner Mullins seconded the motion. All were in favor and the motion passed.
