#### **GENERAL BUSINESS:**

# Hire new employee Circuit Clerk:

Ms. Weible presented the Commission with a request to hire one full time county employee. She stated that her office is one a few Circuit Clerk offices that still process passports, as well as taking on municipal court due to the Fine Collection Center closing. Next month, the new Show-Me Jury will take affect and she anticipates a lot of phone calls because of the new procedure. She stated that she does have discretionary funds available to supplement. Commissioner Mullins said he wished to look at the budget numbers. Commissioner Wilkinson made a motion to take under advisement. Commissioner Mullins seconded the motion. All were in favor and the motion passed.

## Award Bid Family Treatment Court:

Sherrie Hampton, Program Director from the Family Treatment Board. There were 2 bids for treatment services, one from Great Mines Health Center and the other from Presbyterian Children's Home. Ms. Hampton asked the commission that they be allowed to accept both bids and work with both companies because of the different services that they offer. This is a new program, only about 5 months in and she stated that there is still a lot of development that needs to be done. Commissioner Wilkinson made a motion to approve both bids. Commissioner Mullins seconded the motion. All were in favor and the motion passed.

#### Disposal of firearms Sheriff Dan:

Sherriff Dan Bullock addressed the Commission regarding firearms in the possession of the sheriff's office that have been dropped off, and left throughout the years. Hunting and target shooting weapons. A total of 16 firearms. He stated that the ultimate goal is to have all officers to carry the same caliber, same weapon. When a new officer is

hired, they furnish their own weapon and eventually the sheriff's office would like to be able to issue weapons for their officers that are the same. Sheriff Dan would like to go to a local gun dealer and sell them or trade the firearms for a store credit to get closer to this goal. Commissioner Wilkinson made the motion to approve the recommendation. Commissioner Mullins seconded the motion. All were in favor and the motion passed.
