Congenital heart defects, or CHD, is a malformation in the heart muscle present at birth. Roughly every **1 in 100** children born will have a CHD. This means that every 15 minutes a baby is born with a heart defect. 40,000 children are born every year with CHD's and 8,000 of them will not live to see their first birthday. **1,000,000 children will be born each year worldwide with CHD** and 100,000 of them will not live to their first birthday.

The heart is formed within 28 days of conception, so often time's mothers do not even know they are pregnant when the defect occurs. **50 percent of the children born with a CHD will have to undergo at least one life saving surgery in their life.** Once a family has a child with a CHD the risk of having another child with CHD goes from one percent to three or four percent.

The heart is important to every part of the body therefore **CHD effects the entire body.** People with CHD are more likely to have physical delays, learning delays, feeding issues, lower oxygen levels, problems with other organs, hearing loss, and other issues. 50 percent of children with Down syndrome also have a heart defect. Someone with CHD may not just be seen by a cardiologist but speech, physical, and occupational therapist as well. The likelihood of living to adulthood is lower for someone with a complex heart defect.

Congenital heart defects are the most common and most lethal birth defects in all the world. **CHD kills more than all childhood cancers combined.** Yet CHD receives 5 times less funding. Why is this? Because CHD does not have the proper awareness it needs. More funding and research is desperately needed because at this point very little is known about what cause CHD's. **There is no prevention and no cure.**

CHD takes its toll on families. Many children spend days, months, even years living in the hospital. Some families live in the hospital with their children while some children are forced to face CHD alone in the hospital. Families are often face with PTSD, depression, and other issues. I am thankful that I have Christ and the Holy Spirt which is the comforter. Without them I don't know how I could face this.

We knew hardly anything about CHD until after our 20 week fetal anatomy scan. We learned that our son, Kent, had a **single right ventricle, double outlet from that ventricle, pulmonary atresia, mitral atresia, and bilateral SVC's.** To put that in shorter terms **Kent is living with half of a heart.** Without surgery Kent would have died shortly after birth. So far Kent has underwent **three open heart surgeries, been on ECMO (heart and lung bypass), and been to the cardiac cauterization lab four times.** Often times, people ask why not just do a heart transplant. A heart transplant is when there are no other options, it is to trade one set of problems for another, it is not an easy solution, and sometimes even rejected. Heart transplants do not last forever and the list is long already of people who need organs.

In the last decade the **death rate from CHD has decrease by 30 percent.** This is **because of the research** that has been provided. While we do not know what the future holds for Kent, I'm thankful that the Lord has strengthened Kent and shown a miracle through him. **We ask for help shedding light on such and devastating topic and we covet your prayers for us and other families facing CHD.**

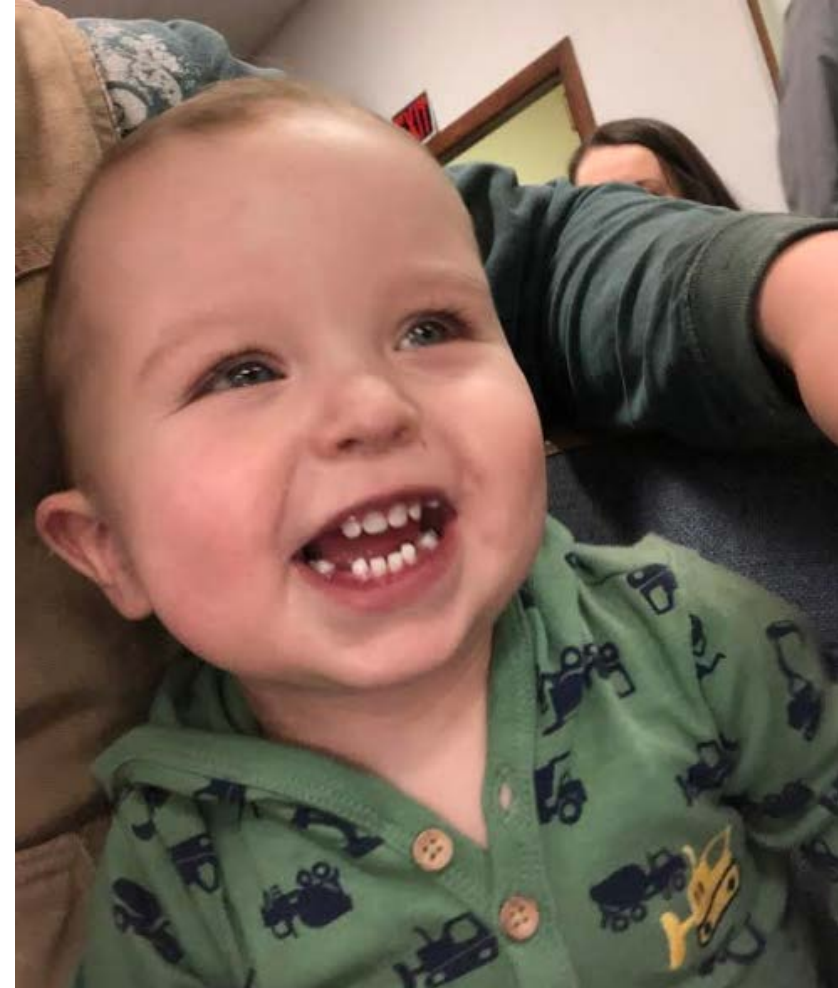

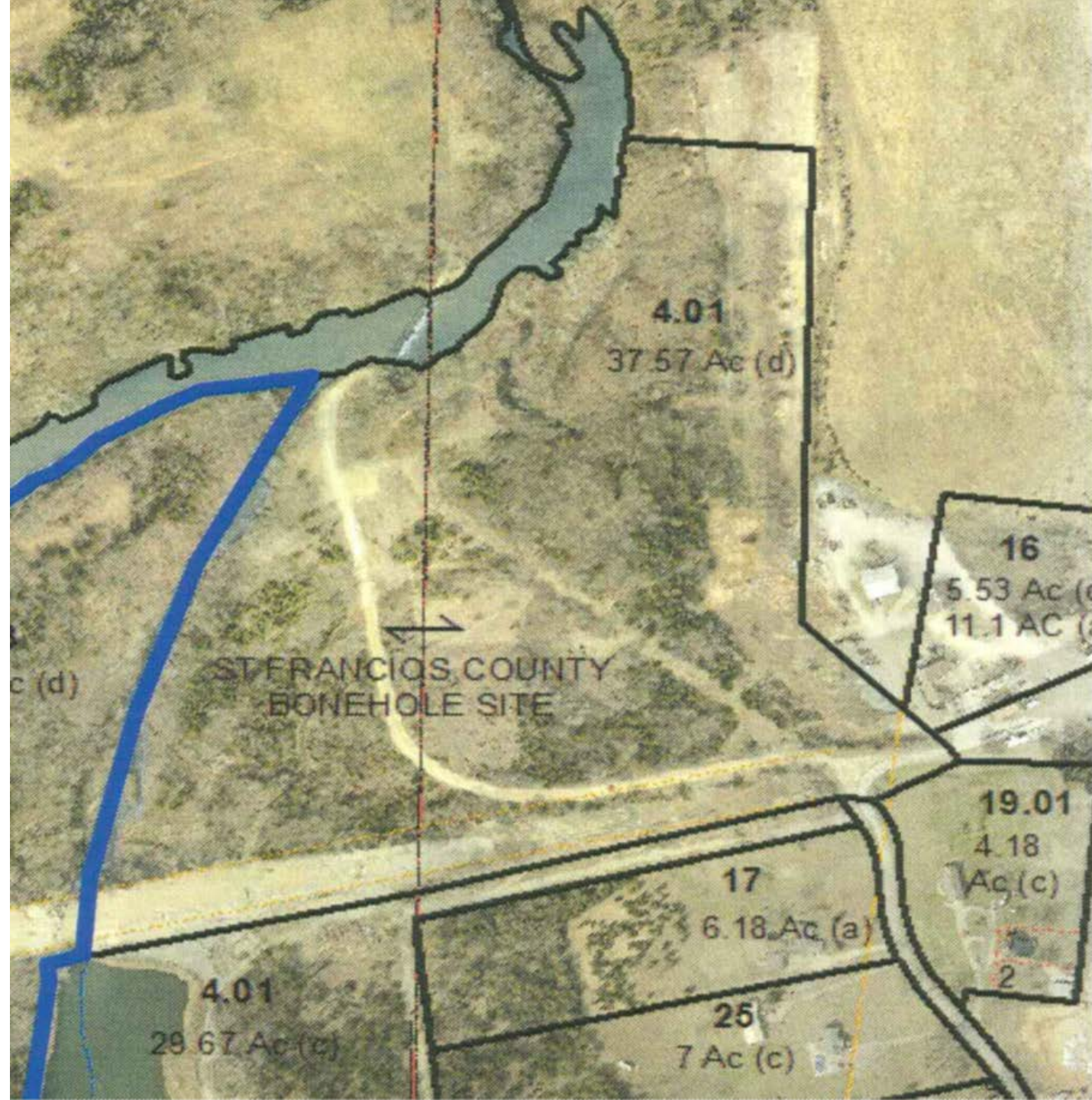
