ST. FRANCOIS COUNTY COMMISSION MINUTES AUGUST 18, 2020 TUESDAY

CALL TO ORDER:

The County Commission met in regular session. GENERAL BUSINESS: REQUEST TO BID STRIPING PROJECT

Hwy Administrator, John Gross is requesting to bid 15 miles of road striping projects. Commissioner Wilkinson made a motion to let out for bid the striping projects. Commissioner Mullins seconded the motion. All were in favor and the motion passed.

REQUEST TO BID ROAD PAVING PROJECTS

Hwy Administrator, John Gross requested to bid 12 miles of road projects for paving overlay. Commissioner Wilkinson made a motion to let out for bid the overlay projects. Commissioner Mullins seconded the motion. All were in favor and the motion passed.

INDEPENDENT AUDITOR'S REPORT/DANIEL JONES & ASSOCIATES

County Auditor, Louie Seiberlich addressed the Commission regarding the independent Audit. Mr. Seiberlich turned the discussion over to Amber Menjoulet, Audit Specialist. Mrs. Menjoulet explained there were no audit findings for the budget year ending 12/31/2019. The Commission thanked the Auditor's office on a job well done. Commissioner Mullins made a motion to approve the draft audit. Commissioner Wilkinson seconded the motion. All were in favor and the motion passed.

REJECT BID PERSONAL PROPERTY MAILING/ASSESSOR & REBID

Bids were opened for the Assessor's Personal Property mailing list on 7/28/2020. There were two bids received. Input Technology, Inc. & divcodata Diversified Companies, LLC. It is the recommendation of Mindy Wooldridge, Deputy Assessor, to reject all bids because the specifications were not met. Mrs. Wooldridge also requested to rebid the assessment list project. Commissioner Mullins made a motion to reject all bids for the mailing list. Commissioner Wilkinson seconded the motion. All were in favor and the motion passed. Commissioner Wilkinson made a motion to re-bid the assessment list mailing. Commissioner Mullins seconded the motion. All were in favor and the motion passed.

JOB TITLE/ PAY INCREASE ASSESSOR

Deputy Assessor, Mindy Wooldridge, ask the Commission to approve a step increase, pay increase for two of her employees. Mrs. Wooldridge is asking to move Lisa Pratt Swoboda from a Clerk 1 to a Clerk 2 position and Jessica Beard from a Clerk 1 to a Clerk 2 position. This raise would be for the 2021 year. Commissioner Mullins made a motion to approve both these positions. Commissioner Gallaher seconded the motion. All were in favor and the motion passed.

SHERIFF SALARY COMMITTEE \$1,000 STIPEND

HR, Corey Scrum, & Deputy Prince Evans came before the Commission to recommend a one-time Stipend allowance of \$1000 for roughly 60 Commissioned Officers. This would help offset the wages for the officers that have been overlooked in the last serval years. Commissioner Mullins made a motion to give the one-time Stipend to the Commissioned Officers. Discussion followed with an amendment made by Commissioner Gallaher to the original motion to include only Commissioned SFC Officers for the Stipend. Commissioner Wilkinson seconded the motion. All were in favor and the motion passed.

SHERIFF SALARY COMMITTEE BID/FIREARMS & BELTS

HR, Corey Scrum, & Deputy Prince Evans came before the Commission to seek permission to bid out firearms & service duty belts. Commissioner Wilkinson made a motion to allow bids to be let for both firearms & belts. Commissioner Mullins seconded the motion. All were in favor and the motion passed.

IT SECURITY SOFTWARE

Dwayne Looney, IT Supervisor, spoke on behalf of IT Director, Jared Faulkner who was absent. Mr. Looney expressed the need for the three (3) IT personnel to have iPads so they could be accessible after hours. The monthly fee is \$80. Mr. Looney explained that the policy committee met, amended the policy and are awaiting legal review, but explained this is a need for priority essential employees. The Commission realizes this matter is time sensitive. Commissioner Wilkinson made a motion to allow IT Staff only permission to proceed with the data plan for the iPads. The iPads are County property & will be used for county business only. Commissioner Mullins seconded the motion. All were in favor and the motion passed.

C.A.R.E.S. PRESS RELEASE

Commissioner Mullins issued a press release regarding the CARES Act application process for reimbursement purposes only. Commissioner Mullins made a motion to accept & adhere to the guidelines of the press release. Commissioner Wilkinson seconded the motion. All were in favor and the motion passed.

C.A.R.E.S. RESOLUTION

Commissioner Mullins presented a Resolution supporting the entities in phase one, two, and three of the C.A.R.E.S funding. Commissioner Mullins read the resolution then made a motion to accept said resolution. Commissioner Wilkinson seconded the motion. All were in favor and the motion passed.
