ST. FRANCOIS COUNTY COMMISSION MINUTES OCTOBER 5, 2020 MONDAY

CALL TO ORDER:

The County Commission met in regular session. Those being present were Presiding Commissioner, Harold Gallaher, Commissioner First District, Gay Wilkinson, and Commissioner Second District, Patrick Mullins. TABLED AGENDA ITEMS:

Wage adjustment union/R&B Employees

Corey Schrum, HR made the recommendation that the Commission accept the wage adjustment for the Road and Bridge department. After some discussion, Commissioner Wilkinson made the motion to approve the adjustment, Commissioners Mullins seconded the motion. All were in favor and the motion passed.

GENERAL BUSINESS:

Petition to vacate road Krystal Wisdom

Petition was brought in for the road closing. Clay Copeland from R&B stated that a notice was posted on-site, local stores, post office and they have not received any input, objections or correspondence. Commissioner Wilkinson made the motion to grant the petition to vacate the road. Commissioner Mullins seconded. All were in favor and the motion passed.

Abandonment of County Rd. – Rice Road

Dan Champan from City of Desloge contacted R&B about the road. The City of Desloge is asking the County to vacate the easement. Commissioner Mullins moved to approve the process of abandonment (3-month process after publication) of Rice Rd. Commissioner Wilkinson seconded. All were in favor and the motion passed, however, later in this meeting the motion was rescinded.

Abandonment of Private easement

Commissioner Mullins was contacted by private land owner, Shelly Bess. She is wanting to abolish easements on her property. Notice was posted, no input, objections or correspondence was received by the Commission. Commissioner Mullins made the motion to abolish the easements. Commissioner Wilkinson seconded. All were in favor and the motion passes.

Addition of Jail Isolation Cell for Covid Protection

Commissioner Gallaher stated that after dispersing the money from the CARES act to the applicants, the County would be left paying for a majority of the addition and it could cost up to one million plus and it wasn't budgeted and could be a risk for the county. There was much discussion and comments from Jamie Crump, Jail Administrator, Kevin Engler, County Clerk, Dan Chapman, City of Desloge, Colin Rodgers with Brockmiller construction along with Jeremy Tanz from the RPC, stating that the Commission does have the option to obligate these funds for this project. Colin Rodgers stated that they could get 70-80% of the project

completed by the end of the year. Commissioner Gallaher made the recommendation to begin the construction. Kevin Engler stated that emphasis should be made that the County intends to use Federally Funded money for the project and Gallaher agreed. Commissioner Mullins made the motion to begin the project, Commissioner Wilkinson seconded. All were in favor and the motion passed.

Appointment to Mental Health Board

President of St. Francois Co. Health Board sent a letter to the Commission asking to make Christopher Massey as trustee. Commissioner Mullins mad the motion to approve the request. Commissioner Wilkinson seconded. All were in favor and the motion passed.

Quarterly Report-University Of MO Extension

Stephanie Schindler from the University of MO Extension gave a quarterly report.

CORRESPONDENCE:

John Gross asked the Commission to discuss Rice Rd. once again. He stated that it is the County's easement and does not require the Commission to petition the land owners. The Commission could allow the City of Desloge to construct a road on the property. It is a request to annex this property into the City of Desloge. Commissioner Wilkinson made the motion to rescind the vote previously made. Commission Mullins seconded. All were in favor and the previous vote was rescinded

Commissioner Mullins made the motion to table the Rice Rd. item. Commissioner Wilkinson seconded. All were in favor and the motion passed.
