CONTINUATION OF PAVING PROJECTS

Highway Superintendent, Clay Copeland came before the Commission to ask the Commission to approve a road project that had been put on hold due to COVID and revenues. Mr. Copeland stated this is the approach to a newly finished Colony Church Road Bridge and it needs to be paved before bad weather starts. Mr. Copeland explained that another bridge approach is being done by Vern Bauman and after speaking to Bauman they assured Mr. Copeland they would be able to get this project done as well at a cost of around \$14,000.00. The Commission will prepare an Emergency letter for this project since there is no time to bid said project and time associated with project. SALE OF SURPLUS PRINTER/PLOTTER

The Assessor is asking permission to sell an HP Designjet 4000ps Printer/Plotter on Gov Deals. Commissioner Wilkinson made a motion to place the printer/plotter on Gov. Deals or Purple Wave. Commissioner Mullins seconded the motion. All were in favor and the motion passed.

HIRE DEPUTY CLERK I ASSESSOR

The Assessor is requesting to hire Misty Hedrick as a Deputy Clerk I. This position is included in the Assessor's 2020 budget and will be filling a vacancy that occurred after the resignation of an employee in the summer of 2019. Commissioner Mullins made a motion to allow the Assessor to hire a new employee. Commissioner Wilkinson seconded the motion. All were in favor and the motion passed.

DESTRUCTION OF RECORDS ASSESSOR'S OFFICE

The Assessor's office is requesting to destroy old records per RSMo 109.260. Commissioner Wilkinson made a motion for the Assessor to destroy 2015 records. Commissioner Mullins seconded the motion. All were in favor and the motion passed.
