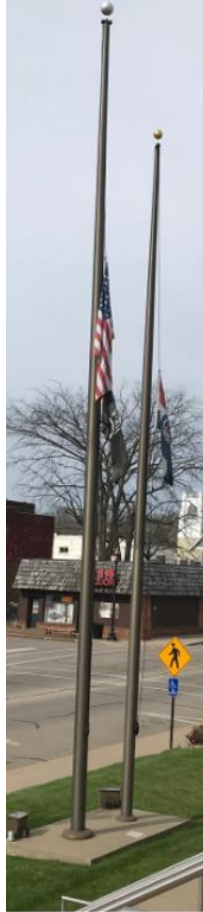
The RAISE grant requested last week will NOT be given.

(On the order of a couple of years!)

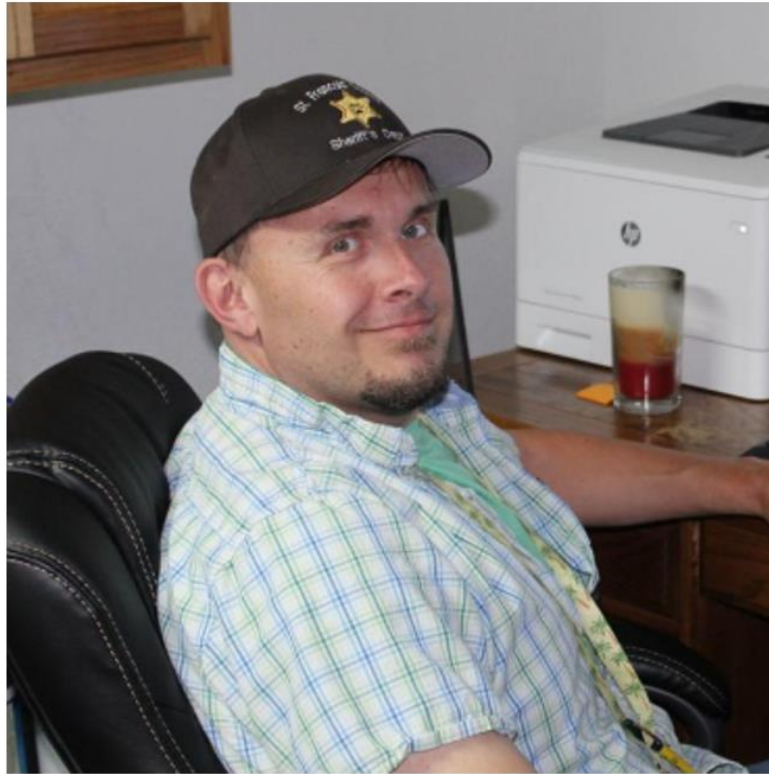
The bridge will now come from ARPA funds as was originally planned.
