High among all Missouri Counties is Christian County at \$18/day + 0.50 /mile

We are currently paying \$0.07/mile + \$18/day if serving and \$12/day if not serving.

9 counties pay \$6 / day plus 0.07/mile. These are the lowest rates and are typically the smallest Counties.

2 counties do not pay anything for the first 2 days of service, then pay \$50/day and 0.07/mile

Most Counties pay some amount per day and 0.07/mile (including St. Louis County). No Missouri County pays less than 0.07/mile.
