RESEAL EXISTING PARKING LOT

CMAR, Colin Rogers, submitted a detailed cost proposal #14 for costs to reseal existing parking lot. The total cost is an add of \$15,959.00 using ARPA funding. CHANGE ORDER #6/LAW ENFORCEMENT CENTER

Commissioner Buckley made a motion to do a change order #6 for cost associated with added asphalt in proposed green space area at the Law Enforcement Center in the amount of \$4,187.00 to be paid for out of ARPA funding. Commissioner Kater seconded the motion. All were in favor and the motion passed.

CHANGE ORDER #2 &#3/ JUVENILE DETENTION

Commissioner Kater made a motion to do a change order for the Juvenile Detention Center. Change order #2 is to replace the cost of the fence in its entirety, added door, building permit, display case, insulation for city code, and install cameras. The amount of #2 changes is \$81,807.18 Change order #3 is to install Cat 6 cable, added door controls, replace cameras, ADA controls at entry and AI phone control station. The amount of #3 changes is \$22,727.00, the entirety is to be paid for out of ARPA funding. Commissioner Buckley seconded the motion. All were in favor and the motion passed.

SPECIAL ROAD DIST 2 COMMISSIONER

The Special Road District would like to reappoint Mr. Larry LaChance of Park Hills to serve as Commissioner until the April 2024 election. Commissioner Kater made a motion to reappoint Mr. LaChance to Park Hills Special Road District #2. Commissioner Buckley seconded the motion. All were in favor and the motion passed.

GOVERNMENTOR BID EXPORTING DATA COLLECTOR'S FILES Collector, Angie Usery, received a bid proposal from GovernMentor to export the Collector's data files to the new software company Devnet conversion. The cost of the proposal will be \$22,425.00 with no additional charges incurred. Commissioner Kater made a motion to approve the bid proposal to be paid for out of Tax Maintenance Fund for the file conversion. Commissioner Buckley seconded the motion. All were in favor and the motion passed.
